# Terms & Conditions

## 1. Bookings, Deposits & Payments

**Confirmation & Guarantees:** All bookings must be secured with valid credit or debit card details within the timeframe requested by the hotel. Failure to do so will result in the automatic cancellation of your booking.

**Deposits:** All deposits and pre-payments are strictly non-refundable and non-transferable. If final numbers decrease after a deposit has been paid, the deposit amount cannot be offset against the remaining final balance.

**Final Balance:** Full payment for all Christmas events is required 4 weeks (28 days) prior to arrival, or as specified in the event brochure. Failure to settle the balance by the specified due date will result in cancellation of the booking.

**Exclusive Events:** Exclusive hire bookings require a signed contract, signed terms, and a £500 deposit is required to confirm your booking. Minimum numbers apply; please confirm these with your Event Co-ordinator.

## 2. Final Details & Dietary Requirements

**Numbers & Pre-orders:** Final numbers, dietary requirements, and meal/drinks pre-orders must be submitted 4 weeks (28 days) prior to arrival. If meal pre-orders are not received on time, the hotel will select the standard set menu for your entire party.

**Dietary Needs:** We are happy to accommodate special dietary requirements provided they are submitted with all pre-orders 4 weeks (28 days) prior to the event. While brochure menus are set, alternative options will be provided for pre-notified dietary requirements.

**Menu Variations:** The hotel endeavours to serve the advertised menus but reserves the right to make operational alterations or substitute menu items without prior notice.

## 3. Cancellations & Alterations by the Guest

**Cancellation Notice:** All cancellations must be confirmed in writing.

**Cancellation Charges:** Cancellations made more than 28 days prior to the event will result in the retention of all paid deposits. Cancellations made 28 days or less prior to the event will incur a 100% charge, and full payment will be retained.

## 4. Cancellations & Alterations by the Hotel

**Operational Changes:** The hotel reserves the right to move events to an appropriately sized function suite, amalgamate smaller Christmas events to ensure vibrant numbers, or change table configurations at our discretion. Seating requests are noted but not guaranteed.

**Minimum Numbers:** The hotel reserves the right to cancel an event if minimum numbers are not met, in which case an alternative date or full refund will be offered.

**Unforeseen Cancellation:** In the unlikely event the hotel must cancel an event for any reason, all monies will be refunded or an alternative date offered, without liability to the hotel.

## 5. Accommodation Bookings

**Rates & Availability:** Christmas and New Year accommodation rates are limited and subject to availability.

**Guarantees & Payments:** Accommodation bookings require a credit or debit card guarantee at the time of booking (accepted cards: Visa, Mastercard, and American Express).

**Accommodation Cancellations:** Individual rooms may be cancelled up to 2:00 PM on the day of arrival. For group bookings of 10 or more rooms or residential packages, a 4-week written cancellation notice is required. Late cancellations or non-arrivals will incur a 100% charge.

## 6. Hotel Conduct & Policies

**Behavior & Entry:** Management reserves the right to refuse entry or require any guest to leave for unreasonable behavior. The organiser or individual will be charged in full for any damage caused to hotel property, furnishings, or equipment.

**Smoking & Vaping:** Smoking and vaping are strictly prohibited inside the hotel.

**Outside Food & Drink:** No external food or beverages may be brought onto the premises for consumption during a function. Gift alcohol must be stored behind reception and not consumed on-site. The hotel reserves the right to request outside items be handed over for storage during the event.

**Dress Code:** The dress code for events is smart casual.

## 7. General Clauses

**Pricing & VAT:** All prices include VAT at the current rate and are subject to change if government tax rates or levies change prior to the event.

**Brochure Accuracy:** Brochure details are correct at the time of printing but subject to change.

**Force Majeure:** The hotel is not liable for failure to perform obligations if such failure is caused by events beyond reasonable control (including fire, flood, extreme weather, war, or terrorist attacks). In severe weather on the day of the event, the hotel reserves the right to postpone by 12:00 PM for safety reasons, offering an alternative date at the earliest opportunity.
